B. The Contractor UK RI, SCIENCE AND TECHNOLOGY FACILITIES COUNCIL, RUTHERFORD APPLETON LABORATORY. Harwell Campus, Didcot, Oxfordshire OX11 0QX, United Kingdom, of the other part

Agreed, accepted and signed the following terms:

Funding of this agreement is reserved by a legally binding obligation, which has received the I.U.N.: 14724/28-06-2024 (9Δ3Y469B7Δ-6IZ) (24REQ015026953), (KAE 2511) entitled "Grants and Subscriptions to Organizations Abroad", (CPV:79980000-7 "Subscription Services"), and is reflected in the University of the Peloponnese, and "Financial Commitment Records" by means of Decision no.: 422/28-06-2024.
4. The assignment of this agreement is approved, for the University of the Peloponnese, by the Rector's Decision no.: 15045/02-07-2024 (24AWRD015055454) and the content of this agreement is approved by the Board of Administration Decision no.: 37/4/15-07-2024 (6YΞ5469B7Δ-H4H)
5. Delivery of the designated goods will be done under the supervision of the Department of Electrical and Computer Engineering, School of Engineering, abiding by the funding principles of the University of the Peloponnese Funding Guide and the varying needs of the project.
6. This agreement shall be deemed to end on: 30/09/2026.
7. Enforcement of the terms and conditions of this agreement shall commence only after its basic terms and conditions (beneficiary data, contract duration, designated task(s) and fee) are uploaded on the "Transparency Initiative" portal (<https://diavgeia.gov.gr/en>), since Administrative Acts and Decisions are not valid unless published online. Consequently, any project related undertaking, prior to the formal reception of a certified Internet Unique Number (I.U.N.), is expressly prohibited.
8. The beneficiary undertakes a contractual obligation not to disclose any confidential information, including any documents, notes, analyses, studies, samples, drawings, flowcharts, databases, models, plans, know-how and software (including source and object codes) to any third parties and violation of this term constitutes a breach of contract.
9. By signing this agreement, the beneficiary provides UoP with his/her consent to collect, keep and process personal data in relation to this agreement or from the documents submitted to fulfil its legal requirements

including those required for its uploading in the “Transparency Initiative” portal in keeping with the conditions laid down by current Law.

10. The terms of this agreement can be altered, amended or modified after the mutual consent of the involved parties.

11. Any dispute concerning the contract is under the jurisdiction of the courts of Tripoli, Greece.
